A: The District will meet in Executive Session for the purpose of considering the appointment, employment, compensation, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear complaints against a public officer or employee, unless such officer or employee requests a public hearing in accordance with Section 551.074 of the Texas Government Code.

 1. Potential transfer of utility services

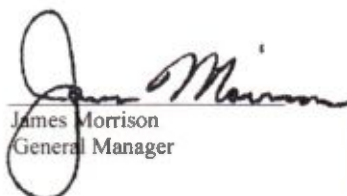
C: The District will meet in Executive Session to deliberate the purchase, exchange, lease, or value of real property in accordance with Section 551.072 of the Texas Government Code.
